银行业扩展分类标准元素清单

银行业扩展分类标准元素是在财政部 2010 年 10 月 19 日发布的企业会计准则通用分类标准（以下简称通用分类标准）的基础上，依据国家标准化管理委员会发布的《可扩展商业报告语言（XBRL）技术规范第 1 部分：基础》（GB/T25500.1-2010）、《可扩展商业报告语言（XBRL）技术规范第 2 部分：维度》（GB/T25500.2-2010）、《可扩展商业报告语言（XBRL）技术规范第 3 部分：公式》（GB/T25500.3-2010）、《可扩展商业报告语言（XBRL）技术规范第 4 部分：版本》（GB/T25500.4-2010）系列国家标准，从企业会计准则、应用指南、会计准则解释（以下简称企业会计准则）等中提取的、适用于 XBRL 报告的财务报告基本概念。银行业扩展分类标准元素清单按照银行业财务报告列报共性内容和扩展链接角色组织，展示了银行业扩展分类标准对财务报告各组成部分的建模方法。

一、概述

本版银行业扩展分类标准中的财务报告概念（元素）总数为 2031 个，其中扩展元素 828 个，直接引用通用分类标准元素 1203 个。元素使用了《可扩展商业报告语言（XBRL）技术规范》（GB/T25500-2010）系列国家标准定义的 3 类元素（替换组）：数据项（Item）、超立方体项（HypercubeItem）和维

度项 (DimensionItem)。

银行业扩展分类标准元素的名称按照计算机能够识别的规则以英文名称。为便于广大会计人员和公众理解，元素清单中以银行业扩展分类标准元素的中文列报标签为展示基础，将元素按照所归属的扩展链接角色 (ELR) 和银行业财务报告列报内容顺序组织排列后形成列表，以更好地说明元素的含义和元素间的层次关系。

元素清单按照企业会计准则的列报要求展示了银行业扩展分类标准的元素层级以及其中的元素，同时包含了元素的类型信息 (如文本，货币等)。

二、元素清单主要内容说明

元素清单按具体的银行业财务报告列报内容顺序列示了所有元素，在每个财务报表部分中按扩展链接角色 (ELR) 组织元素。元素清单主要包括两列内容：元素层级、元素类型 (如下图所示)。

第一列——元素层级

元素清单的第一列代表了银行业扩展分类标准的元素层次结构：

1. 元素按照银行业财务报告列报内容逐项列示。
2. 银行业扩展分类标准在逻辑设计上将财务信息关系分成组，每组关系被视为一个整体进行处理。扩展链接角色（ELR）是一组可被视为一个整体

进行处理的财务信息关系的标识符。银行业扩展分类标准将财务信息关系按照财务报表主表和附注分成若干扩展链接角色，每个扩展链接角色对应一个的财务报表、附注或附注中一张表格。例如，资产负债表可被作为一个扩展链接角色，附注-现金及存放中央银行款项也可被作为一个扩展链接角色。

扩展链接角色（ELR）的编码为6位数字，其中前两位“90”表示银行业扩展分类标准，后四位由银行业扩展分类标准按照一定顺序进行定义。例如，“[900101] 合并资产负债表”对应于银行业财务报告列报内容的“合并资产负债表”，编码“900101”的后四位“0101”为该合并资产负债表在财务报告中的顺序号。另外，对于引用通用分类标准的部分链接库，直接使用通用分类标准中的扩展链接角色的编码。例如，“[330105] 本行利润表”对应于通用分类标准中的“[330105] 个别利润表_商业银行”。

3. 每个角色下列示归属于这个角色的所有元素，缩进的位置代表了元素的层级。

第二列——元素类型

元素清单的第二列主要列示了元素的数据类型，如货币型。为便于广大会计人员和公众理解，元素清单根据银行业扩展分类标准的实际使用情况，将其中一些数据类型转为较易理解的名称，如“stringItemType”转为“text（文本）”、“escapedItemType”转为“text block（文本块）”；将一些虚元素的种类视同元素数据类型，以帮助理解银行业扩展分类标准的建模方法。元素清单

第二列的含义说明如下：

1. text block——文本块，其内部可包含表格；
2. text——文本，内部为纯文本；
3. yyyy-mm-dd——时点；
4. X——货币型；
5. X.XX ——数值型；
6. shares——股份数；
7. table——维度化的表格；
8. axis ——维度化表格的轴；
9. member——维度化表格轴上的成员；
10. line items——维度化表格的列报事项；
11. 空白代表没有需要披露的数据项类型信息。
