石油和天然气行业扩展分类标准元素清单

石油和天然气行业扩展分类标准(以下简称石油行业扩展分类标准)中的元素是在通用分类标准的基础上,依据国家标准化管理委员会发布的可扩展商业报告语言(XBRL)技术规范系列国家标准,按照石油行业财务报告共性实务提取的适用于 XBRL 报告的财务报告基本概念。石油行业扩展分类标准元素清单按照石油行业财务报告共性实务和扩展链接角色组织,展示了石油行业扩展分类标准对财务报告各组成部分的建模方法。

一、概述

本版石油行业扩展分类标准中元素总数为 1087 个,其中扩展元素 446 个,直接引用通用分类标准元素 641 个。

石油行业扩展分类标准元素的名称按照计算机能够识别的规则以英文命名。为便于广大会计人员和公众理解,元素清单中以石油行业扩展分类标准元素(包括扩展元素和引用的通用分类标准元素)的中文列报标签为展示基础,将元素按照所归属的扩展链接角色和石油行业财务报告共性实务的顺序组织排列后形成列表,以更好地说明元素的含义和元素间的层次关系。

元素清单按照企业会计准则的列报要求,展示了石油行业扩展分类标准 的元素层级以及其中的元素,同时包含了元素的类型信息(如文本、货币等)。

二、元素清单主要内容说明

元素清单按石油行业财务报告共性实务的顺序列示了所有元素,在每个 财务报表部分中按扩展链接角色组织元素。元素清单主要包括两列内容:元 素层级、元素类型。

第一列——元素层级

元素清单的第一列代表了石油行业扩展分类标准的元素层次结构:

- 1. 元素按照石油行业财务报告共性实务逐项列示。
- 2. 石油行业扩展分类标准将财务信息关系按照财务报表主表和附注分成若干扩展链接角色,每个扩展链接角色对应一个的财务报表、附注或附注中的一张表格。
- 3. 每个扩展链接角色下,列示归属于这个角色的所有元素,缩进的位置 代表了元素的层级。

第二列——元素类型

元素清单的第二列主要列示了元素的数据类型,如货币型。为便于理解, 元素清单根据石油行业扩展分类标准的实际使用情况,将其中一些数据类型 转为较易理解的名称,如"stringItemType"转为"text(文本)",

"escapedItemType"转为"text block (文本块)";将一些虚元素的种类视同元素数据类型,以帮助理解石油行业扩展分类标准的建模方法。元素清单第二列的含义说明如下:

- 1. text block——文本块,其内部可包含表格;
- 2. text——文本,内部为纯文本;
- 3. yyyy-mm-dd——时点;
- 4. X——货币型;
- 5. X.XX ——数值型;
- 6. shares——股份数;
- 7. table——维度化的表格;
- 8. axis ——维度化表格的轴;
- 9. member——维度化表格轴上的成员;
- 10. line items——维度化表格的列报事项;
- 11. 空白代表没有需要披露的数据项类型信息。
